



## Glen Oaks Swimming & Tennis Club Membership Agreement

- I. This agreement is between \_\_\_\_\_ (“Member”) and the Glen Oaks Swimming & Tennis Club (“Club”). Member agrees to pay all applicable dues and fees required. Member is permitted to full access of the club.
- II. **MEMBERSHIP TYPES.** Member has selected the following type of Club Membership:
- \_\_\_\_\_ **SINGLE MEMBERSHIP:** The Single Membership cost is \$480 per year and is billed at \$40 per month. Individuals 15 years of age or older. No children or spouses are included.
- \_\_\_\_\_ **COUPLE MEMBERSHIP:** The Couple Membership cost is \$600 per year and is billed at \$50 per month. Couples living at the same address without children or with all children in the Freshmen year of high school or older.
- \_\_\_\_\_ **FAMILY MEMBERSHIP:** The Family Membership cost is \$1080 per year and is billed at \$90 per month, per family. All family members must be living at the same address.
- III. **MEMBERSHIP BILLING POLICY.** Members who pre-pay dues in a single annual payment receive one month free. Members making monthly payments are required to set up recurring monthly payments using a credit card or checking account. Any Member that fails to pay monthly fees for 60 days shall have their membership suspended until all back dues and fees are paid in full. Members who fail to pay their dues or fees within 90 days, shall have their membership terminated and their debt referred to collection.
- IV. **TERMINATION RIGHTS.** Member may terminate this contract for any reason at any time after the initial membership term selected in paragraph II is fulfilled. A 30-day written notice is required to cancel membership. If the member rejoins the club within a 12-month period of the termination, the member will be subject to a re-initiation fee, ½ year of membership, in addition to the membership term selected from paragraph II.
- V. **GUEST FEES.** Member may bring guests to the Club to use the facilities provided the Member is current with their dues and fees and the Member has paid the “Guest Fee” of \$7 per guest per day.
- VI. **WAIVER OF LIABILITY.** Members agree they are familiar with the risks and perils inherent in all activities conducted at the Club, aware of the risks of personal injury to themselves and/or their family and guests when undertaking such, and voluntarily assume and, in the absence of gross negligence or recklessness, hereby release the Club, its successors and/or assigns, including agents, officers, and employees of the Club and its successors and/or assigns, from all risks associated with their use of the property. Members agree to hold the same harmless in the absence of gross negligence or recklessness for all losses of personal property or damage to personal property, including theft, associated with their use or presence on Club’s property.
- VII. **ANNUAL WORK OBLIGATION.** Members agree to participate in at least four hours annually of general Club maintenance. A minimum of two workdays will be set aside to facilitate this obligation. Failure to comply with this requirement shall result in a \$50 annual charge to Member billed in September of each year.
