



## **Glen Oaks Swimming & Tennis Club Membership Agreement**

I. This agreement is between \_\_\_\_\_ (“Member”) and the Glen Oaks Swimming & Tennis Club (“Club”). Member agrees to pay all applicable dues and fees required. Member is permitted to full access of the club.

### **II. MEMBERSHIP TERM**

Member agrees to a 12-month initial membership term.

### **III. MEMBERSHIP TYPES.**

**Single:** \$540 per year (paid annually or billed at \$45 per month). Individuals 15 years of age or older.  
No children or spouses included.

**Couple:** \$720 per year (paid annually or billed at \$60 per month). Couples living at the same address without children or with all children in the Freshmen year of high school or older.

**Family:** \$1320 per year (paid annually or billed at \$110 per month). Families with all children.

### **IV. MEMBERSHIP BILLING**

Membership is billed with a single annual payment or recurring monthly payments using a credit / debit card or checking / savings account. Processing fees apply to credit / debit card transactions. Annual members receive one month free when making an annual payment. Membership will be suspended after 60 days of non-payment and terminated after 90 days of non-payment. All uncollected dues will be turned over to debt collection. A reinstatement fee of \$150 will apply to all suspended memberships.

#### **A. SELECT MEMBERSHIP LEVEL AND BILLING TYPE**

\_\_\_ **Family Annual:** \$1210 (Normally \$1320, before 1 month free with annual payment).

\_\_\_ **Family Monthly:** \$110 per month, 12 payments paid via recurring payments.

\_\_\_ **Couple Annual:** \$660 (Normally \$720 before 1 month free with annual payment).

\_\_\_ **Couple Monthly:** \$60 per month, 12 paid payments paid via recurring payments.

\_\_\_ **Single Annual:** \$495 (Normally \$540, 1 month before free with annual payment).

\_\_\_ **Single Monthly:** \$45 per month, 12 payments paid via recurring payments.

#### **B. SELECT PAYMENT TYPE**

Payment is processed through QuickBooks. Initial Annual or recurring payment links will be emailed to members via our QuickBooks system.

**V. TERMINATION RIGHTS.**

Member may terminate this contract for any reason at any time after the initial 12 month membership term is fulfilled. A 30-day written notice is required to cancel membership. If the member rejoins the club within a 12-month period of the termination date, the member is subject to a re-initiation fee, ½ year of membership, in addition to a new 12-month membership term.

**VI. GUEST FEES.**

Guests may accompany members to the club provided the Member is in current standing. Guests may not be onsite without the Member host present. The guest fee is \$10 per day, per guest.

**VII. ANNUAL WORK OBLIGATION.**

Members agree to participate in at least eight hours annually of general Club maintenance. A minimum of two Member workdays will be set aside to facilitate this obligation. Failure to comply with this requirement shall result in a \$100 annual charge to Member billed in September of each year.

**VIII. WAIVER OF LIABILITY.**

Members agree they are familiar with the risks and perils inherent in all activities conducted at the Club, aware of the risks of personal injury to themselves and/or their family and guests when undertaking such, and voluntarily assume and, in the absence of gross negligence or recklessness, hereby release the Club, its successors and/or assigns, including agents, officers, and employees of the Club and its successors and/or assigns, from all risks associated with their use of the property. Members agree to hold the same harmless in the absence of gross negligence or recklessness for all losses of personal property or damage to personal property, including theft, associated with their use or presence on the Club's property.
